GUEST REGISTRATION for RANGES

In return for use of premises, use of the ranges, instruction in firearms, use of the lake and/or for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, the Undersigned agrees to the following: To indemnify, hold harmless and defend the Winchester Isaak Walton Club, DBA the Winchester Chapter of the Izaak Walton League (hereinafter "WIWL") and any of its members, directors, officers or instructors from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with my discharge of firearms or use of the Premises; the Undersigned's participation in discharging firearms; observing the discharging of firearms, the range, buildings, land, including the lake, and premises used (the "Premises"); the Undersigned's presence on or use of Premises; and any and all acts or omissions of the Undersigned. The Undersigned acknowledges the risks and unexpected damages involved in the use of firearms, and that the use of, loading and unloading firearms, and being in the presence of firearms is inherently dangerous, and assumes all risks of injury to person and property that may be sustained in connection with the stated and associated activities, in and about the Premises. Should any such claim, demand or lawsuit arise or be asserted in any way related thereto, whether arising under the laws of the United States or Virginia, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend the WIWL from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against WIWL, whether individually, jointly, or in concert with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned waives any and all rights and claims for damages, losses, demands and any other actions, which exist or which may arise against the WIWL, (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: discharging firearms, the Premises, and any latent defect in the Premises; the Undersigned's presence on or use of Premises; the Undersigned's property (whether or not entrusted to the WIWL); the WIWL shall not be liable for, and the Undersigned hereby expressly releases the WIWL from any and all such claims. This waiver is both personal and on behalf of any minor for whom it is executed.

The Undersigned hereby expressly assumes the risk of entering the Premises and taking part in activities on the Premises which include, but are not limited to the discharge of firearms and the firing of live ammunition; or observing individuals discharging firearms; and/or the use of the club, the lake or camping facilities.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all WIWL lake rules, range rules, procedures, safety rules, and any and all Range Officer instructions, whether communicated in writing, posted on the premises and/or communicated verbally.

This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs and any minor for whom it is signed.

GUEST REGISTRATION INSTRUCTIONS

WIWL Members in Good Standing who are Range Qualified may bring up to two guests to shoot on the WIWL ranges at a time.

The host member is responsible for his/her guests while they are on the range, must supervise their shooting, and so may not shoot while their guests are shooting.

The host member is responsible for ensuring that each guest complies with posted range policies and procedures.

To register a guest, please:

- Fill out in full and sign the Guest Registration Form for each guest – the forms are located next to the Treasury Drop Box next to the right hand office door;
- Cut/tear off the receipt on the base of the Guest Registration Form and ensure that your guest(s) can present this to any member on request as proof of registration;
- Place the top, main section of the duly completed Guest Registration Form(s) in a Treasury Drop Box envelope and include the \$10 contribution to range maintenance per guest, cash or check; and
- Seal the envelope and drop it into the Treasury Drop Box located next to the right hand office door in the Field House.
