	Range Guest Policy							
	WIWL Members in Good Standing who are Range Qualified (members who have completed Chapter Orientation and yearly requalification) may bring up to two guests at a time to shoot on the WIWL ranges. The host member must sign their guest in at the Chapter House and is responsible for his/her guests while they are on the range, must supervise their shooting, and so may not shoot while their guests are shooting. The host member is responsible for ensuring that each guest complies with posted range policies and procedures. To register a guest, follow the							
	instructions posted in the Chapter House. Now Therefore: The first three full paragraphs of the WIWL Range Rules and							
	Standard Operating Procedures are amended to read as follows: Effective as of February 6, 2020

Range Guest Policy

WIWL Members in Good Standing who are Range Qualified may bring up to two guests at a time to shoot on the WIWL ranges. The host member must sign their guest in at the Chapter House and is responsible for his/her guests while they are on the range, must supervise their shooting, and so may not shoot while their guests are shooting. The host member is responsible for ensuring that each guest complies with posted range policies and procedures. To register a guest, follow the instructions posted in the Chapter House.
